COVID-19 - General Awareness Training

This training covers tips on how to reduce the risk of contracting the virus by using best practices. In addition, the course covers COVID-19 characteristics, related health and safety concerns, wearing proper personal protective equipment, and disinfecting and sanitation best practices. This course teaches best practices on these topics as published by the CDC and OSHA. Time to complete: 10-15 minutes.

Supervisor Guide - Returning Back to Work

This course helps supervisors and managers prepare for when they and their employees return to work. It covers tips to help with employees' stress and anxiety, summarizes OSHA recommendations for a safe workplace, and provides an overview of employee leave options related to COVID-19. Time to complete is 5-10 minutes.

COVID-19 - CISA Guidance for Essential Critical Infrastructure Workforce

A memorandum from the Cybersecurity and Infrastructure Security Agency to help State, local, tribal, and territorial officials as they work to protect their communities, while ensuring continuity of functions critical to public health and safety, as well as economic and national security.

Sample Furlough Letter - English

A letter template that can be used to give employees notice of a company furlough.

Telework Agreement - English

A template agreement between employer and employee that describes the expectations for working from home.

Work from Home Policy - English

A policy outlining the expectations laid out by the employer for employees who work remotely.
